District Business:

Grant Applications Update

Federal Assistance to Firefighters Grant: The grant application was completed and accepted by FEMA. Results should be released later this year.

State Representative funding: We will be completing a letter of interest to State Representative Gomberg to fund a classroom type facility located within our training grounds.

Property Annexation: WE are working with property owners, the county and ODF to annex 45.7 acers into the fire district. The property is located on Beavercreek Road. Over the last Year we have worked with the owners to make the property meet access and water supply standards prior to annexation.

99.1% spent

Ending fund balance: \$15,337.54

Materials and Services Funds:

82.5% spent

Personnel:

Our two newest Resident Volunteers have started their onboarding process. One has successfully completed their EMT basic certification, and the other is currently in their EMT basic class. We will be working with them individually to obtain their Fire fighter certifications with their hands on skills training occurring with their assigned shifts.

Training Activities:

Department level training in June continued the focus on wildland operations, including water supply, structure protection, and multi-company operations. In July, the training focus changes to rescue operations.

A number of career staff and volunteers achieved professional milestones in June, including Firefighter I (Kendra Islam) and Fire Officer I (Andrew Licon). Will Beede and Josh Eskenazi (pictured) were certified to operate our Type 6 wildland brush engines. Both are participating in the OSFM-supported staffing program this summer. Their ability to drive and pump our wildland engines increases the departments capabilities considerably during the height of fire season.



Apparatus/Equipment:

Chief Eddy and LT. Schell replaced the door lock assembly on 293 (Ford 150)

Hose testing has been completed for the year. 500 feet of 2.5-inch hose was removed from service secondary to failure.

Building/Property Update:

Part-time personnel funded through the OSFM grant have worked to clear brush from around the grounds of station 203 and district pump sights.

Hydrant Mapping/Painting:

Part time staff are working on locating and mapping all the hydrants within the district. Hydrant caps are being painted to match NFPA flow rates.

Community Involvement/Meetings:

Chief Eddy along with District Volunteers assisted with the instruction of The FRIEND STEM Fire Camp, providing instruction to 18 high school aged students in basic firefighting skills and CPR/First Aid certification.

Significant calls:

6/1/26: Philomath Fire and Rescue was dispatched at 3:26 pm for Automatic Aid to Hoskins-Kings Valley Rural Fire District for a Large Wildland Fire on Kings Valley Highway. Upon arrival, fire was approximately .5 acres in grass and blackberry bushes. Crews assisted with incident command, were assigned to mop up on the northern edge of fire and provided water supply to H-KVRFPD. (see attached photos).

6/2/26: Philomath Fire and Rescue was dispatched at 11:12 am for a Structure Fire on North 16th Street. Upon arrival, found a small fire on the exterior of the structure. The fire included an enclosure housing a pet tortoise, Blu. The fire involved part of the enclosure, and some damage to the siding of the home. Crews quickly extinguished the fire. Blu was found in the enclosure un-harmed and handed over to the owner. No extension of the fire was found in the nearby home.

6/6/26: Philomath Fire and Rescue was dispatched at 4:42 pm to a Motor Vehicle Crash with Injuries on SW Airport Ave. Upon arrival, Corvallis Fire Department crews were on the scene providing care to a single motorcycle rider. PF&R crews checked for any needed assistance and returned to quarters.

6/11/26: Philomath Fire and Rescue was dispatched along with Corvallis Fire Department and Monroe Rural Fire Protection District at 8:59 am to a Structure Fire on Highway 99. Upon arrival, crews found an 8'x15' outbuilding with heavy smoke showing. A farm employee with a water truck was attempting to extinguish the fire. CFD was assigned to fire attack and PF&R crews provided additional manpower. MRFPD was cancelled prior to arrival. The scene was turned over to Benton County Sheriff's Office to secure for Oregon State Fire Marshal to complete the fire investigation.

6/13/26: Philomath Fire and Rescue was dispatched at 5:06 pm to a Motor Vehicle Crash with Injuries on Highway 20. Upon arrival, crews found at a two-vehicle head on collision at highway speed, glancing contact. One patient was transported by Corvallis Fire Department Ambulance. Additional vehicle occupants denied injury and declined medical assessment or treatment. Scene turned over to Law Enforcement.

6/14/26: Philomath Fire and Rescue was dispatched at 3:58 pm to an All-County Fire Response with Corvallis Fire Department on SW West Hills Road. Upon arrival, crews found a fully involved vehicle fire that was spreading to ground cover and tree limbs. Fire was extinguished, overhauled and containment completed.

6/22/26: Philomath Fire and Rescue was dispatched at 5:15 pm to a Smoke Investigation near Fern Road. While responding to the incident, Oregon Department of Forestry contacted PF&R Crew to inform them they had already responded to that location earlier and it was a large slash pile. PF&R Crew confirmed that this was the same incident. Other responding apparatus were canceled prior to arrival.

6/23/26: Philomath Fire and Rescue was dispatched at 12:39 am to a Structure Fire on N 8th Street, upon arrival, the fire was in a small shed involving the wall surrounding the chimney of the wood stove. Crews extinguished the fire and returned the scene over to the resident.

6/26/26: Philomath Fire & Rescue was dispatched at 2:05 pm to a Motor Vehicle Crash with Injuries on Main Street/26th Street. Upon arrival, crews found a two-vehicle motor vehicle collision with moderate damage to both vehicles. One driver assessed and transported by Corvallis Fire Department Ambulance; second driver declined a medical assessment. Scene turned over to Philomath Police Department.

6/28/26: Philomath Fire & Rescue was dispatched at 2:21pm to a Structure Fire on Bailey Street and responded with 18 personnel in two engines, heavy brush truck, three water tenders, and a command vehicle. Automatic aid was provided by Corvallis Fire Department and Monroe Rural Fire Protection District. Upon arrival, crews found that the barn was located behind the residence and was 20 ft by 30 ft in size. Crews attacked the fire from the exterior. The fire was placed under control within 36 minutes from initial dispatch, crews continued to mop up the fire and cleared the scene. There were no injuries reported.

6/29/26: Philomath Fire & Rescue was dispatched at 3:37 pm to a Small Miscellaneous Fire on Ash Street. Upon arrival, crews found a 2x4 foot area of burned grass on north side of road. Crews made sure fire was out. Remnants of fireworks in the street adjacent to fire were located. Philomath Police Department was notified about the incident.

6/30/26: Philomath Fire & Rescue was dispatched at 10:38 am to a Large Wildland Fire on Coon Rd/Cherry Creek Road in Monroe Rural Fire Protection District. Philomath crew staged at Monroe Fire Station for district coverage during their fire incident

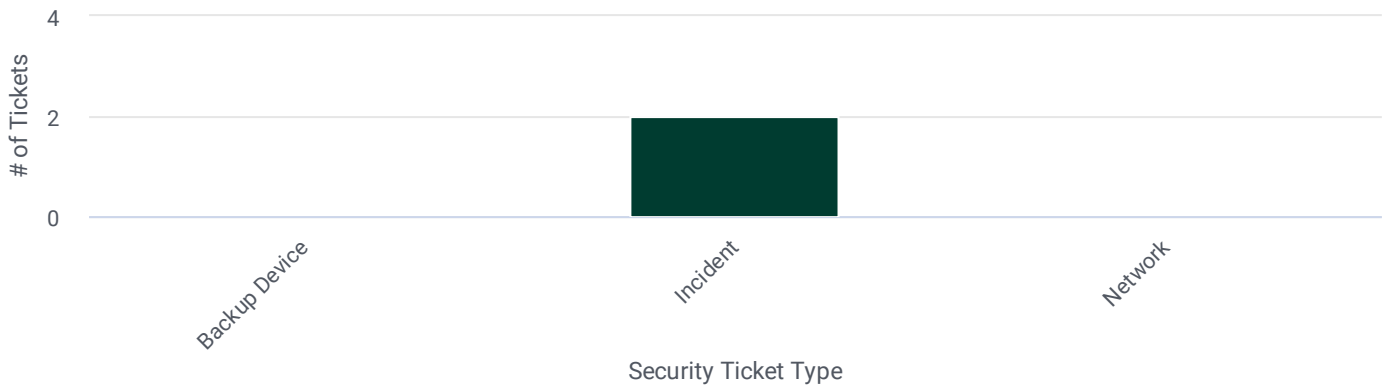

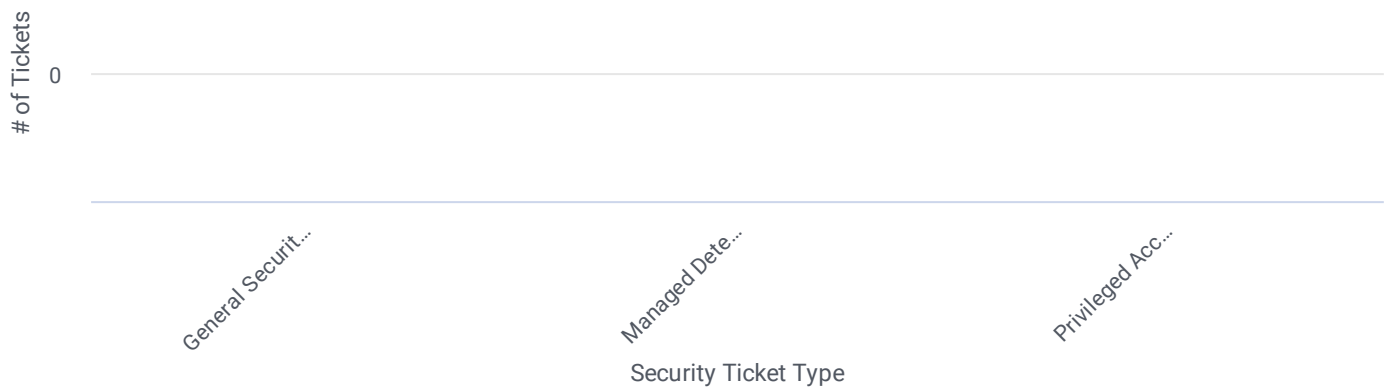
