Bridges and Access Roads and Gates...oh my!

If you live in the Philomath Fire District, in our rural areas, and you have a **private bridge** or a culvert that travels under your driveway, we want to talk to you. Currently the District has 50 known private bridges in our response area. Unfortunately, 28 out of the 50 private bridges

cannot be crossed with our fire equipment including our medical response vehicles. Many bridges are not engineered for the weight of our vehicles and others we simply don't have any information about their load capacity. We have a list of bridges that are OK TO CROSS. If you are unsure whether or not your bridge is on that list, please call Captain Rich Saalsaa, our Fire & Life Safety Officer, at 541-360-0029. We can talk to you about what needs to be done to get your bridge certified by a State approved bridge engineer. It is important to know that your bridge can be safely crossed for fire and life safety purposes as well as for fire insurance purposes. Uncertified bridges can delay response to your home in an emergency.

Later in the year and in Spring we will be conducting a survey of driveways and access roads to ensure that we can safely access your property in case of a fire or life emergency. Current Oregon Fire Code and Linn-Benton Fire Protection Standards call for a minimum of a 16foot drivable surface that can hold 60,000 pounds gross vehicle weight, plus an additional 2-feet of clearance on each side of the road, for a total of 20 feet of clearance. Bridges follow the same minimums and include additional requirements like turnout areas on either side of the bridge. **Overhangs** on driveways can impede response as well. There should be a minimum of 13 ½ feet clear over the road or approach. Clear away any low branches or other overhanging obstacles.

Gates across any access roads or driveways also must have a minimum of 16-foot width and if the gate is lockable, we recommend having a KNOX brand padlock in addition to your own padlock so that emergency responders can quickly gain entry without having to cut your chain or cable.

Lastly, there are **grades** to consider. Generally, driveway or approach grades should be 10% or less. There are exceptions if you have a residential sprinkler system installed inside your home.

We know that some older driveways and access roads were constructed in compliance with earlier versions of the Fire Code. While we cannot compel anyone to come up to the latest standard we would like to work with you to ensure timely emergency response to your home.
